

Your commission will be issued in the variation of your name that you choose. This can be your full legal name or a shortened version that you prefer to use. For instance, if your full legal name is Gloria Ann Smith, you may choose to register as a notary public under the name Gloria A. Smith. However, when signing as a notary public, you must use the exact name on your commission.

Some examples of commonly used suffixes are Sr., Jr., and III.

Leave this line blank it will be completed by the American Association of Notaries as your insurance agency.

You must sign in the name you will use when acting as a notary public. For instance, if you print the name Gloria A. Smith in # (1), you must sign Gloria A. Smith.

All applications will be reviewed for accuracy before being hand-delivered or electronically filed with the secretary of state.
